SENIOR SCHOOL | FEE SCHEDULE | 2017

The School Fee is an **annual fee** which, for the convenience of parents, is charged each term. The Term Instalment is **due for payment on the first day of term**. Outstanding fees are subject to an Administration charge of 3% of balances carried forward to the next term. **The Board may refuse permission of re-entry of a student if any Fee for any preceding term has not been paid.**

Notice of Withdrawal: One (1) terms notice in writing OR one (1) terms fees are required in lieu of notice given before the withdrawal of a student, except in the graduating term for Higher School Certificate students. This notice is also required in the case of boarders becoming day students.

Enrolment Fee

The School charges a once only payment of \$800 which must be paid on acceptance of enrolment and must accompany the completed Application for Enrolment form. The fee is usually paid in the year preceding enrolment. **Applications for Enrolment will not be processed unless accompanied by the Enrolment Fee.** This is a non-refundable fee.

Fee Statement of Account

A Fee Statement of Account is issued prior to the commencement of each school term. This Account includes Tuition and Boarding Fee, Lunches, Disbursements and the Half Term Charge. Another Fee Statement of Account is issued mid-term reflecting only Disbursements, Half Term Charge and any monies outstanding from previous accounts.

Lunch:

Day students have the option of using the School Dining Hall. The lunch form will be included with the First Term Fee Statement.

Discounts

The Fee Discount Policy applies only to Tuition Fees and/or Boarding Fees. No other Fees are subject to this Discount Policy. Where more than one discount is applicable the discount percentage applies to the full fee amount. Once the cumulative discount percentage reaches 50% no further discounts shall be allowable. For students in receipt of a Merit Scholarship (Academic, Music, ICPA, All Rounder, etc) no further discount will be allowable once the Merit Scholarship, together with any discount has reached 50% of total fees. Where a Merit Scholarship of 50% or more is offered then no further discount will apply.

When any Discount, Family concession, Scholarship or Bursary reaches 50% on cumulative Tuition Fees and/or Boarding Fees no other Discount, Family Concession, or Bursary will apply.

Family Concessions

The School grants a fee concession to siblings attending the School simultaneously:

Eldest student in family	Full Fee
1st Sibling	10%
2nd Sibling	20%
3rd and subsequent Siblings	30%

Payment of Fees in Advance

An allowance is available to Parents who wish to pay a year's fee by the first day of First Term or half year's fee by the first day of Semester. The Bursar will be pleased to assist you to take advantage of this offer. Fees are payable at the beginning of each term.

Enrolments After Commencement of a Term

When a student commences at the School after the Term has commenced, enrolment will be accepted with payment of the Enrolment Fee, with the Term fee being charged at a pro rata rate. Pro rata fees are calculated as a proportion of the annual fee.
