

# Equestrian Team Riding and Agistment Agreement at Scots campus

Dear Parent,

This agreement relates to \_\_\_\_\_ (Student) and \_\_\_\_\_ (Horse)

The following outlines the agreement: *(some statements are not applicable to non agistee's)*

1. The payment of agistment (if applicable) will be billed in each half term account. Your son/daughters agistment will be *(to be filled by the MIC Equestrian and returned to you)*

2. Agistment (if applicable) is in term time only; all horses are to be removed from Scots All Saints College, Scots Campus grounds during School holidays.
3. Agistment (if applicable) will be billed on the mid-term accounts each term. A parent's inability to keep up to date with school fees/accounts may result in the loss of privilege to agist at Scots All Saints College, Scots Campus.
4. Before horses arrive at the Scots All saints College Agistment Centre, Scots Campus they must have current Tetanus and Strangles vaccinations. They must also be drenched prior to arrival at the beginning of each term. Horses should also have been recently shod/trimmed by a farrier.
5. Students are responsible for the daily care and feeding of horses. The MIC equestrian will oversee this. Animal Welfare is paramount and if an animal is not being cared for then a warning will be issued to the student. After 2 warnings a meeting will be held with the parents to discuss the future agistment of the horse.
6. Students are responsible for the cleaning of manure from paddocks and placing this in the compost. Shared paddocks MUST be cleaned weekly, private yards daily. This will be monitored and inspected regularly. Failure to comply with this rule will result in the area being cleaned by a staff member and billing of \$50 being placed on students account.
7. Your son/daughter may ride or attend to their horses on days that do not conflict with other compulsory school commitments such as cadets and sport.
8. Your son/daughter MUST sign out and in from the boarding house and verbally let a boarding house resident on duty know that they are going to the equestrian agistment area and estimate their time of arrival back to the boarding house.
9. You understand and accept that your son/daughter will often be attending their horse and riding unsupervised by a staff member.

10. Your son/daughter MUST have the MIC of Equestrian and the boarding house phone numbers on a fully charged and working mobile phone on all occasions when at the equestrian agistment.
11. Under NO circumstances are other NON EQUESTRIAN students to be taken to the equestrian centre to accompany your son/daughter unless the MIC Equestrian and the boarding house staff have been notified and permission granted for this student to accompany your son/daughter. This student must have a signed note from a parent and have signed an indemnity. Therefore this student must be prearranged prior to the activity.
12. UNDER NO CIRCUMSTANCES are other students able to ride your son/daughter's horse.
13. UNDER NO CIRCUMSTANCES is your son/daughter able to ride another student's horse.
14. UNDER NO CIRCUMSTANCES is your son/daughter able to jump unless supervised by the MIC Equestrian, an approved supervisor, an instructor or by yourself (the parent of the rider)
15. UNDER NO CIRCUMSTANCES is your son/daughter to ride on Scots All Saints College grounds other than the agistment area and Lee Street Oval unless supervised by the MIC Equestrian.
16. Students MUST NOT ride on the cricket pitch at Lee Street Oval and in the case of wet weather they must not ride on the cricket oval either.
17. Students are able to organise private instruction at School but the instructor must be an accredited coach and have their own insurance. They must be approved by the MIC Equestrian and the School before they begin coaching at Scots All Saints College. Insurance and WWCC numbers must be submitted to the MIC equestrian prior to the instructor coming to teach on the school grounds.
18. Your son/daughter MUST be a current financial member of Equestrian Australia for insurance purposes.
19. The school holds no responsibility for any injury that occurs to any horse. They hold no responsibility for any damage or loss of any personal horse gear/equipment. All horses and gear are kept on the school premises at the owner's own risk.
20. It is the responsibility of the parents of the rider to transport or organise transport to and from events/training days. The school does not provide horse transport.
21. You acknowledge that Equestrian activities by their very nature are dangerous and that accidents causing death, bodily injury, liability and property damage can, and do happen. You agree that the school shall be under no liability whatsoever for the death or any bodily injury, loss or damage which may be sustained or incurred by the equestrian activities undertaken except in regard to any rights you may have arising under the Trade Practices Act 1974 (Commonwealth or similar State Legislation).

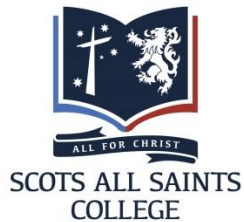
